



## **AQUADILLO GRANT INFORMATION AND APPLICATION**

### **What is An Aquadillo Grant?**

An Aquadillo grant is a reduced rate for program fees for the Aquadillo summer swim program. Program fees may be discounted 25% - 100% depending upon need and available funds, as determined by the Aquadillo Board of Directors. There are no grants available for swim equipment, team suits, etc.

### **How does a person apply for an Aquadillo Grant?**

The parent or guardian of a current team member or a prospective team member must complete the following process by March 25, 2020:

1. Complete the attached Grant Application. All financial information provided will remain confidential. Coaches and other team members will not be informed of a team member's grant status.
2. Complete all Aquadillo registration materials for the current swim season.
3. Email the completed application to [president@aquadillos.com](mailto:president@aquadillos.com) by March 25, 2020.

Grant applicants will be notified by April 5, 2020 regarding the status of their application for a grant for reduced program fees. If an application for a reduced program fee is approved by the Aquadillo Board of Directors, the reduced program fee must be paid in full by April 10, 2020 and registration completed in order for the swimmer to participate in any practices, activities or meets. The registration for the current swim season will not be considered complete until after the scholarship is approved and the balance is paid in full.

**DUE TO INSURANCE CONCERNS AND THE REQUIREMENTS OF THE POOL LEASE WITH THE CITY OF GEORGETOWN, THE GRANT ATHLETE MAY NOT PARTICIPATE IN SWIM PRACTICES OR MEETS UNTIL THE BALANCE HAS BEEN PAID IN FULL.**

### **Who is eligible to receive an Aquadillo grant?**

All swimmers who are eligible to participate in the Aquadillo summer swim program are eligible to apply for a grant. Eligibility for a discount in program fees will be determined by the Aquadillo Board of Directors, in its sole and absolute discretion, but the number of immediate family members in the household of the swimmer and their combined income from all sources will be considered, along with the amount of discount being requested. "Income" for purposes of the Aquadillo grant application shall mean gross income (i.e. before deductions from taxes, insurance premiums, union dues, bonds, social security taxes and other employee deductions). Income also includes net income from self-employment, social security, public assistance, child support payments, alimony, regular contributions from people not living in the same household, monetary compensation for services such as wages, salary, commissions for fees and other cash income.
