Finals Tasks

- **Attending A- vs. B-Finals – JULY 12 DEADLINE**

- If you are **available** to swim at A-Finals, select Attending for the A-Finals Preliminaries. If not, select Not Attending.
- If you are **available** to swim at B-Finals, select Attending for the B-Finals Preliminaries. If not, select Not Attending.
- If you are available for both finals, you should select Attending for both.
- Coach Eric will determine the A-Finals lineup based on the top times of the swimmers available for A-Finals. Each club sends their top two swimmers for each event and one team for each relay. The B-Finals lineup will be determined based on those swimmers available for B-Finals but are not swimming in A-Finals. There is no limit to the number of swimmers for B-Finals.
- We will notify you on July 18 as to which swimmers are swimming which finals.

- **Happy Ads – JULY 16 DEADLINE**

- For only \$5 (cash or check to Woodbrooke Hills Swim and Tennis) you can support your swimmer with a Happy Ad in either the A or B Finals program. Happy Ads are about ½ the size of a business card.
