## **2019 NEW ADULT MEMBER/YOUNG FAMILY/ACTIVE MILITARY APPLICATION AND AGREEMENT**

The undersigned hereby offer to purchase an adult household membership in the Rancho San Miguel Swim Club, a nonprofit corporation, subject to the terms and conditions listed below.

1. Adult membership applies to a household in which all members are aged 18 and older. Additionally, this membership applies to young families and active duty service members. The applicant agrees to pay the annual Dues of \$300 and the refundable Annual Maintenance fee of \$175. The Annual Maintenance Fee will be refunded upon fulfilling the Member's responsibility for participating in five (5) hours of Club sponsored maintenance activities. In the event your application for membership is not approved, fees and dues submitted with this application will be returned to you within 10 days of the date of disapproval.
2. The term Young Families includes two adults and one child under the age of two years old or multiple births under the same birthdate. Once the child(ren) is/are over the age of two or another child is added to the membership, the membership will be switched over to a family membership.
3. The term Active duty service member includes all men and women of the armed services serving actively in the Armed Forces (in either active or reservist status). Once the member is no longer active and/or retires from said service branch that member will be expected to notify the board of their retirement, termination or deactivation within 30 days to be re-evaluated for membership.
4. If the applicant(s) is (are) of the age of 60 years or older, the maintenance fees will be waived. The applicant must provide the board proof of their age to receive the waiver.
5. This membership is subject to the bylaws of the corporation now in effect or as amended hereafter, including but not limited to provisions for termination of the membership on death or nonpayment of dues.
6. The membership purchased under this agreement shall not be assignable without the prior written consent of the Club.
7. I have read the By-Laws and the Rules of the Rancho San Miguel Swim Club (available online). I agree to be bound and to abide by the Bylaws and the Rules and regulations established for the use and enjoyment of the Club's recreational facilities.
8. I recognize that there are risks inherent in the sport of swimming, which could result in paralyzing injuries or death. On behalf of myself and all adult members of my household, I hereby agree to indemnify and hold harmless the Rancho San Miguel Swim Club (hereafter Swim Club), its officers, employees, volunteers, instructors, and agents against any liability for personal injury or property damage that may occur while participating at the Swim Club as a result of not only our own actions, inactions, or negligence, but also from the actions,

inactions, or negligence of others, the condition of the facilities, equipment, or areas of the Swim Club.

9. I further certify that I and all adult members in my household are in good health and have no physical condition that would prevent participation at the Swim Club. Furthermore, I agree to use our personal medical insurance as a primary medical coverage payment if accident or injury occurs. I consent to emergency medical treatment in the event such care is required.
